 - a. **Chairman Poole, Vice-Chairman Scholes, Trustee Hulse, Superintendent Jacobson, and Clerk Hagan all present.**

- IV. **INFORMATION ITEMS/REPORTS**
 - a. COVID-19 (Coronavirus) Updates:
 - i. Extended School Closure (State Board of Education closure until April 20, 2020): State department of Education has not given any criteria information on the extended soft closure. They will be holding a meeting later this week with more information. The Governor will be holding a press conference on Wednesday at 11 with more information on the states stay-at-home order that was set through April 15th, 2020. The Board had a discussion about extending out SVE school closure.
 - ii. Virtual Learning (Teacher Report if available): K-2 report: most students are reporting daily. The workload has been modified this week. A lighter workload has been given to students. 3rd/4th report: Things are going good for the students that are doing the work. There has been a 100% attendance in class, however only about 2/3rds of the work is being done and submitted. No one has complained about the workload and said that it was an appropriate amount of work. 5th/6th report: 100% attendance in class everyday so far but will be missing some students this week and worry about more absent students after this week. The students who do well with school and don't need a ton of motivation are doing well. The students that need motivation are having a hard time submitting work and getting assignments turned in. All the teachers have been utilizing Mrs. Chelsea Lundquist to reach out to parents to help motivate students to get their assignments done and turned in.
 - iii. Staff Work expectations, School Operations, Special Education Services & Classified Staff: Maintaining office hours from 9-12. Paraprofessional staff have been taking on some new roles with Special Education Services and helping teachers by motivating parents and students to get work done. We are utilizing staff for some projects that need some attention around the school. We are hoping that we will have more direction from the state at the next meeting. Teachers are looking for directions for the end of the year. They have questions about the last week and when we are wanting to finish the school year. They are asking for direction in the next couple of weeks so they can plan accordingly.
 - iv. Transportation: Still waiting on direction from the State. Our bus drivers would like to stay on with the school and not be 'laid-off' during this time. The drivers have training that needs to be done and they can come in a clean their buses. We may utilize them in other areas if we need to.
 - v. Food Service Program: We are not using our food service for meals in our district. She is doing webinars every week and reports for the state. If we need to utilize her in other areas, we can.
 - vi. School Policies: No new policies since the last meeting.
 - vii. Idaho State Achievement Test (ISAT) & Idaho Reading Indicator (IRI): Still no updates on IRI.
 - viii. Governor Little's 1% budget cut: Have not received any more updates.
