- 4. Chairman Scholes called for a motion to adopt the proposed agenda, Mrs. Poole so moved to adopt the Agenda, Mrs. Hulse seconded. The motion passed unanimously.
- 5. Chairman Scholes ordered the minutes from June 5, 2018 board meeting to stand as read.
- **6.** Chairman Scholes ordered the minutes of Board Work Session Minutes from June 19, 2018 to stand as read.

 - c. Still accepting applicants for Business Manager position, open until July 20, 2018. Teacher and staff were asked to help interview potential hire.
 - d. Asked about any student fees dating back to 2013 for curricular or extra-curricular activities. Trying to get removed from the Blanket Law-suit to say we never charged fees, need to send a letter head to get the school dismissed from law-suit.
 - e. The school received a \$5,000 library grant to buy books for the library, hoping to get that by the end of August. Targeting early grades.
 - f. ISBA Annual Convention Boise, ID November 14-16: Booked 2 rooms. Highly encourage the new business manager to attend.
 - g. Continuous Improvement Plan Due by October 1, 2018: emailed board what is on school web site. Asking for input to improve on. Approve it by September meeting. Go over it August meeting.
