- Call to Order: Chairman Pauline Scholes called the meeting to order at 7:03 and led the board and audience
 in the Pledge of Allegiance.
- 2. Roll Call: Chairman Pauline Scholes, Vice-Chairman Jessica Poole, Trustee Diane Hulse. Others in attendance: Superintendent Michael Jacobson and Board Clerk Fran Howell.
- Chairman Scholes called for a motion to adopt the proposed agenda. Mrs. Poole so moved. Mrs. Hulse seconded. The motion passed unanimously.
- 4. Chairman Scholes ordered the minutes of the 7/12/17 board meeting to stand as read.
- 5. The board reviewed the accounts payable and there were several questions. Chairman Scholes called for a motion to pay the bills. Mrs. Poole so moved. Mrs. Hulse seconded. The motion passed unanimously.
- 6. The board reviewed the current budget and there was a small discussion.
