a. 54.8% Tier 1 (at grade level) Fall 2020 51.7%  
b. 19.4% Tier 2 (near grade level) Fall 2020 20.7%  
c. 25.8% Tier 3 (below grade level) Fall 2020 27.6%  
vi. Lead Water Update: Project is finished. 4 new drinking fountains with filter systems in the school and a filter system in the basement. The school has passed off on being monitored for lead in the water.
