- Superintendent Report
 - Spring Break: While the school was out on break, we scheduled a few appointments to happen. We scheduled a pressure test for the existing hot water loop, and the updated Surveillance system.
 - Spring Music Talent Show is tomorrow, April 7th at 2pm. We have several students signed up for the talent show and they are really excited!
 - Asbestos Management Report: We had an inspection done on March 18th. We will be getting a report soon. We are back on track, and everything looked good to the inspector. The inspector said we had no issues with our asbestos.
 - Surveillance System was installed over spring break. We have added new cameras and have coverage for the whole school inside and out. This is so nice to have done and have full coverage of the property. Two new TV's we put into the office, on the Superintendents office for easier viewing.
 - Grades 1-4 Field Trip to the Artitorium on March 16th. The 1st-4th grade teachers used their PTO budget that they receive each year. The students and staff had a great time. They are so happy to be back on track with field trips!
