V. INFORMATION ITEMS/REPORTS

- a. Superintendent Report
 - i. 5K Fun Run was held on Friday May 26th. The weather was great and so was the turnout.
 - ii. 8th Grade Graduation was on Tuesday the 23rd. We had 6 student graduate this year.
 - iii. 8th Grade Lagoon Trip was on Wednesday the 24th. The students had a blast. The weather was great and they stayed until they closed down the park.
 - iv. ISAT 2022-23 Testing Preliminary Results: ELA 80.6%, Math 58.1%, and Science 45.5% of students proficient or advanced
 - v. ISAT 2021-22 Results: ELA 77%, Math 60%, and Science (Not Available) of students proficient or advanced
 - vi. Spring 2023 IRI - 71.4% of students in K-3 scored in Tier 1 (Tested 26 students)
 1. Fall 2022 76.9 % of students in K-3 scored in Tier 1 (Tested 21 students)
 - vii. Quarter 4 K-8 Attendance 93.9%, 16 K-8 and 5 PK Students 100%/ YTD 92.1%
 1. 2021-2022 Q4 K-8 Attendance 93.9%, 16 K-8 and 5 PK Students 100%/ YTD 92.1%
- b. Health Insurance for 2023-24 School year: A discussion was held regarding the ISBT insurance that the school currently has and the State insurance plan. The board discussed the benefits of both insurance plans.
- c. Swan Valley School District #92 2023-24 Budget: Small discussion was held.
- d. Swan Valley School District #92 Superintendent Contract: Board held a discussion.


