- c. COVID-19 (Coronavirus) The following is a list of potential discussion items as needed.
 - i. Governor Little extended Stay at Home order until April 30, 2020. After the 30th there will be a 4 stage reopen for the state of Idaho.
 - ii. Extended School Closure Currently Swan Valley until May 1, 2020. A discussion was held on hours required for the state for each grade. Waivers were submitted but no information will be received regarding waivers until after school has ended for the year. The boars discussed the last day of instructional hours be May 15th and the week of May 18th 22nd be returning materials and cleaning out personal items. No new instruction for the last week of school.
 - iii. Virtual Learning: Teachers reported that the students are starting to be tardy and miss more school then they did in the beginning of remote learning. The teachers all agree that its been harder to keep attention in the classroom. Teachers are worried that this will get worse with the nicer weather coming in May.
 - iv. Swan Valley School Operations: Today we started opening up for Special Education Service one on one with students and teachers. The teachers and students are keeping a safe distance. Today went really well and it was so nice to see the students.
 - v. Idaho Reading Indicator (IRI) testing will start May 1st for Kindergarten 3rd grade.
 - vi. Instructional Hour Waiver Request: Submitted hourly waiver request specific for 4^{th} grade. We will not hear back from the state until after school ends. If we continue through the 22^{nd} we will not have to worry about making up hours, even if the state denies our request.
 - vii. Impacted Average Daily Attendance Request: Submitted a request for the 4 days prior to spring break.
 - viii. Quarter 4 Grading Proposal: Discussion was held regarding the grading system listed below.
 - 1. Skillful 87%-100%-demonstrated a high skill level of the standards
 - 2. Proficient 70%-86%-demonstrated a basic skill level of the standards
 - 3. Insufficient below 70%- inadequate evidence or skills shown of the standards
 - ix. Discussion was held regarding Governor Little 1% hold back for 2019-20 School Year. No new information has been given.
 - x. Discussion was held for 2020-21 School Year estimating 5% hold back. Not much information ahs been given on this topic. Hopefully more info will come soon.
