- Superintendent Report
 - School Security: The Secure Our Futures Grant interior doors have been ordered and should be installed in August.
 - ii. HVAC Update: The HVAC project has been postponed until summer 2025 due to backordered items. The end of May, we received a phone call informing us that some parts were backordered 27 weeks, putting the HVAC project on hold. III Phase power will be installed, and some other maintenance projects that were going to be held off until next year will be done this summer.
 - iii. ISAT 2023-24 Testing Preliminary Results: ELA 70.6%, Math 41.2%, and Science 54.5% of students proficient or advanced
 - ISAT 2022-23 Testing Results: ELA 80.6%, Math 58.1%, and Science 45.5% of students proficient or advanced
 - iv. Spring 2024 IRI 57.9% of students in K-3 scored in Tier 1 (Tested 19 students)
 - 1. Fall 2023 IRI 68.2% of students in K-3 scored in Tier 1 (Tested 22 students)
 - v. 2023-24 School Year K-8 Attendance 93.2%
 - 1. 2022-2023 School Year K-8 Attendance 93.2%
- b. Swan Valley School District #92 Policy 5400: Discussion was held regarding personal days. With the school calendar being a 4 day, the board decided to look into personal days for school year 24-25.
