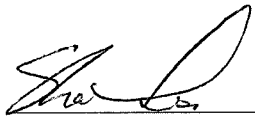


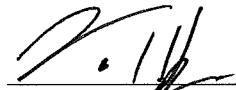
Regular School Board Meeting Minutes

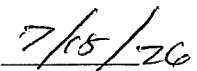
