
- I. **CALL MEETING TO ORDER**
  - a. Vice-Chairman Poole, Trustee Hulse, Superintendent Jacobson and Clerk Hagan all present. Chairman Scholes arrived at 6:30PM.
- II. **Vice-Chairman Poole led the Pledge of Allegiance**
- III. **CONSENT AGENDA - ACTION ITEMS:** Vice-Chairman Poole Called for a motion to approve the Consent Agenda. Trustee Hulse motion to approve the Consent Agenda. Vice-Chairman Poole Seconded. 2- In-Favor. 0 – Opposed.

- IV. **BOARD GOALS – STARTS AT APPROXIMATELY 6:00 PM:** A discussion was held with Trustee Hulse and Vice-Chairman Poole along with a few patrons regarding future board goals. No goals have been set at this time. The board discussed setting measurable goals when setting goals and smaller stepping stones to get to bigger goals. Patron input for this discussion had some great ideas for free and relatively cheap training resources to help inform our teachers and staff on behavioral health encounters such as; bullying, anxiety issues, emotional and psychological health. The board will set a follow-up meeting to discuss the goals that they would like to put in place. The board got great ideas and this was a great starting point.
- V. **SWAN VALLEY SCHOOL GYM EXPANSION PRESENTATION – STARTS AT APPROXIMATELY 6:30 PM:** Stan Marshall gave an informational presentation on the Proposed Gym expansion. Stan discussed how the cost of the proposed gym had come into place. Stan answered several questions that the patrons had for him. This presentation was to inform the patrons on his background of working with schools on new buildings and additions he has done in the past and to give suggestions on things that the community may want to think about if/when the gym expansion moves forward.

  - a. Superintendent Report
    - i. Thursday May 30, 2019 – 8<sup>th</sup> Grade Graduation: 5 students were in the graduation 8<sup>th</sup> grade class. The graduation went really well.
    - ii. Monday June 3, 2019 – LED upgrade, \$6,224.00 rebate
    - iii. 4<sup>th</sup> Quarter attendance 95.5% & 19 students 100%, YTD 96.1% & 5 students 100%
    - iv. ISAT – Preliminary Results: ELA 69.7%, Math 57.6%, and Science 53.8% of students proficient or advanced
    - v. IRI – 73.7% of students in K-3 scored in Tier 1, 100% of 3<sup>rd</sup> grade scored a Tier 1
    - vi. The New bus was delivered today, June 17<sup>th</sup>. The '98 bus is gone. Superintendent Jacobson will go into town this week and get the plates transferred over and loaded into iBus.


