1. Call to Order:

- 4. Agenda Adoption:

- d. Chairman Hicks called for a motion to increase adult breakfast and lunch by ten cents and student lunch by 10 cents for the 2015-2016 school year. Mr. Steffes so moved. Mr. Lundquist seconded. The motion passed unanimously.
- e. Chairman Hicks called for a motion to use our buses to transport students for the 2015-2016 school year. Mr. Steffes so moved. Mr. Lundquist seconded. The motion passed unanimously.
- f. Chairman Hicks called for a motion to adopt the proposed 2015-2016 school budget. After some discussion, Mr. Steffes so moved. Mr. Lundquist seconded. The motion passed unanimously.
