- a. Hiring of School Employee(s): The board discussed the hiring of Lisa Harrison for the part-time seasonal custodian position and hiring Melanie Jacobson for the part-time paraprofessional position.
- Combined District Plans Due October 1: Discussion was held with the board regarding the following plans:
 - i. College and Career Advising and Mentor Plan
 - ii. Literacy Plan
 - iii. Continuous Improvement Plan
- c. Re-Opening Plans for 2020-21 School Year revisions: A discussion was held with the board. The board discussed changes that have been made to the plan. Highlights: Assigned seating for bus routes and for the cafeteria, Buses will be dropping off students at the gym, temp checks done every day for staff and students, regular handwashing built into classroom schedules, all drinking fountains are turned off and the water filling station is the only fountain working. Students need to bring water bottles. The plan will be updated, and placed on the website and sent out to parents.
 - i. COVID-19 (Coronavirus) The following is a list of potential discussion items as needed.
 - 1. Transportation: New bus routes, masks required on the bus and assigned seating.
 - Guidance for each grade level
 - a. Pre-School: The board of trustees held a discussion regarding Pre-k. The board would like to decide on a Pre-K schedule at the next board meeting. The board has discussed having all 7-8 students in class 4 days a week with one teacher and will make final decisions on September 15th.
 - b. Kindergarten: A discussion was held. Kindergarten will be held half days during the COVID-19 restrictions. Kindergarten will be picked up on the bus in the morning and parents/guardians will need to pick students up at noon.
 - c. 1-2: All students have desks and the teacher has structed her day differently to accommodate social distancing the best she can. No issues.
 - d. 3-4: No issues. Mrs. Lundquist mentioned that she would like to explore the option of having another aide this year.
 - e. 5-6: No issues.
 - f. 7-8: This class is a bit more challenging for social distancing due to the fact that there are 16 students in the class.
 - Extra-Curricular Activities:
 Music: A slight concern with sanitizing all the instruments and singing. She is
 working on trying to get all of that figured out.

Art: Starts Friday.

Sports: No travel outside of the valley for sports at this time. Coach will hold co-ed volleyball practice on days we are in school. Coach is working on scheduling games with staff, parents, and co-ed games to help develop skills. A wide discussion was held with patrons and the board.
